#### **PART-TIME FIREFIGHTER** **Fire Services**

The Liberty County Board of Commissioners is currently accepting applications for **Part-Time Firefighters** within the Fire Services Department. This position is responsible for fire suppression operations, rescue, emergency medical assistance, and assistance to the public. This position will have direct contact with the public and must be able to deal with difficult situations in a professional manner. Applicants must demonstrate a drive to help the public and assist in the wellbeing of those we are called to assist.

Applicants must possess a High School Diploma (or its equivalent) and a current Georgia State Registered Volunteer Firefighter or higher certification.
