

NOTICE REGARDING UNOFFICIAL ELECTION RESULTS

The election results released this evening by the Liberty County Board of Elections and Registration represent an unofficial tabulation of ballots cast in connection with the June 9, 2020 elections. These results specifically include, among other election contests, all local races (e.g. Sheriff, County Commission, Board of Education, etc.). These results *do not include* ballots cast in connection with the March 24, 2020 Presidential Preference Primary and the TSPLOST Special Election before its rescheduling to June 9, 2020. An unofficial tabulation of these votes will be made available tomorrow, June 12, 2020. **ALL RESULTS ARE UNOFFICIAL.**

The Board again thanks the candidates and the public for their patience and support during this election, which presented uncommon challenges due to the COVID-19 public health emergency and a new statewide voting system. Official election results will be certified to the Georgia Secretary of State as soon as practicable.

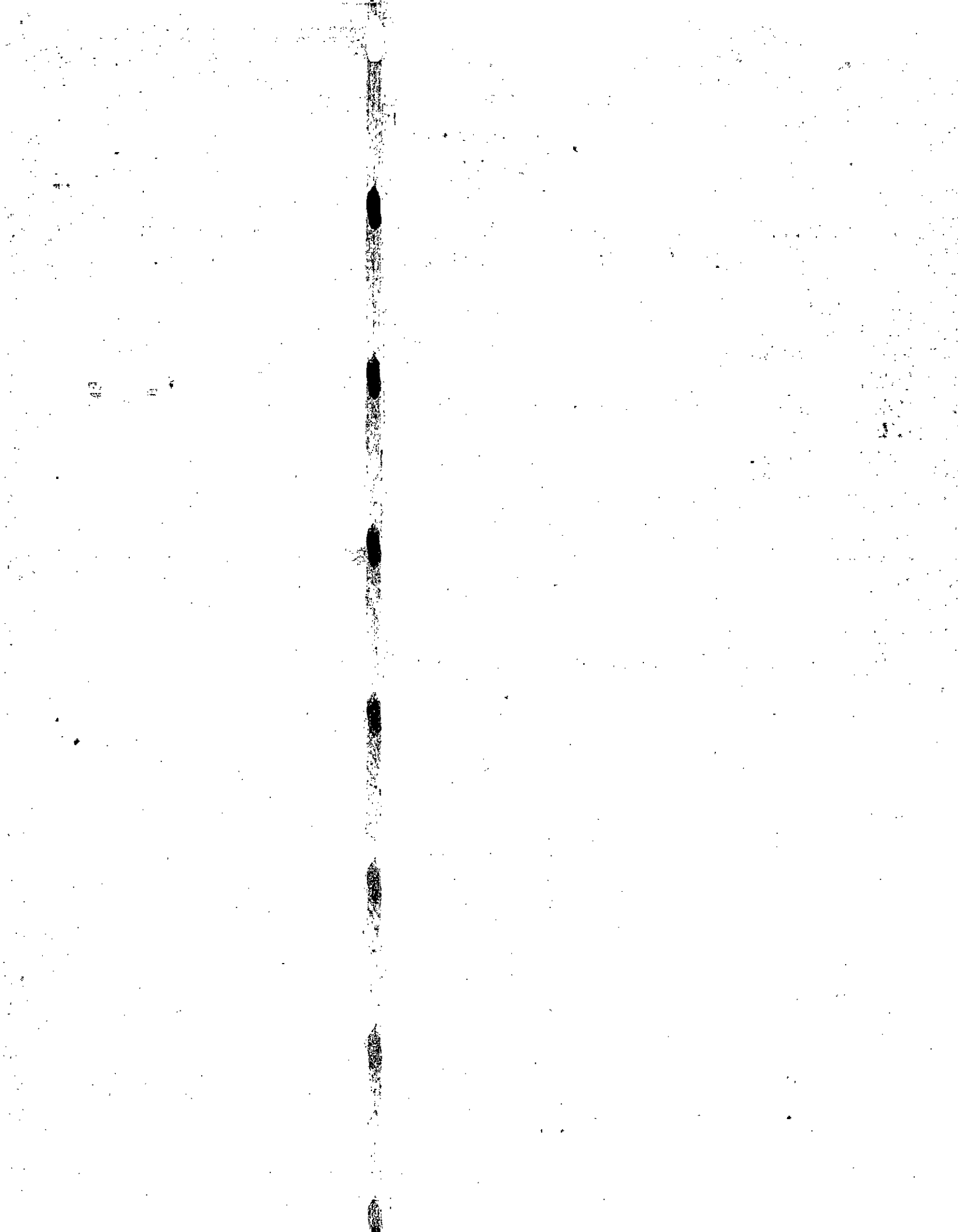

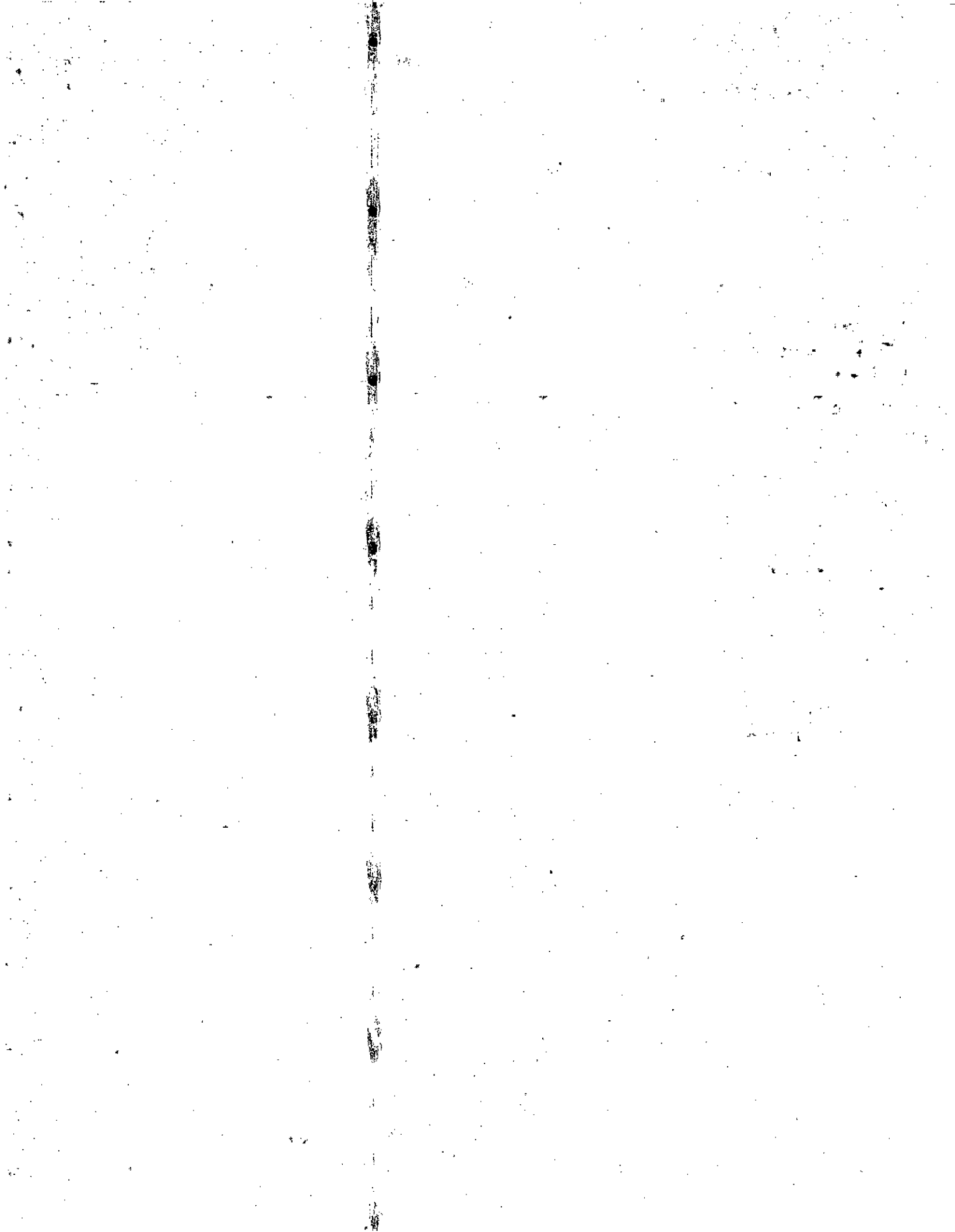
